## DICKINSON LAW RECOGNIZED FOR COMMITMENT TO DIVERSITY, EQUITY, AND INCLUSION

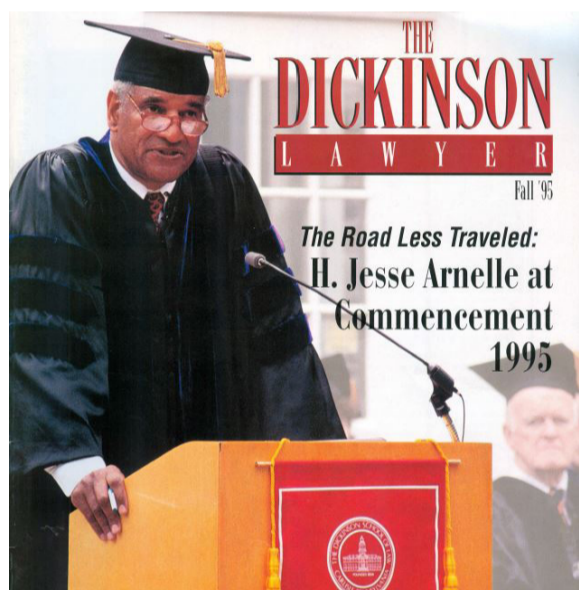

Dickinson Law reflects on the legacy of H. Jesse Arnelle '62, who died last month. Whether he was in the classroom, in the courtroom, or on the basketball court, he stood out. A 1955 graduate of Penn State, Arnelle played a leadership role in Dickinson Law's merger with Penn State in 1997 and established the Law School's first scholarship in support of diversity, which has awarded nearly \$120,000 since 2000. Professor of Law and H. Laddie Montague Jr. Chair in Law Laurel Terry recently published in the *Georgetown Journal of Legal Ethics* an article on the global networks among lawyer regulation stakeholders. Her article, which is entitled *Lawyer Regulation Stakeholder Networks and the Global Diffusion of Ideas*, provides several examples that illustrate the ways in which U.S. lawyer regulation stakeholders are connected to global networks. A three-time Fulbright recipient, Professor Terry writes and teaches about the impact of globalization on the legal profession, especially with respect to regulatory issues.

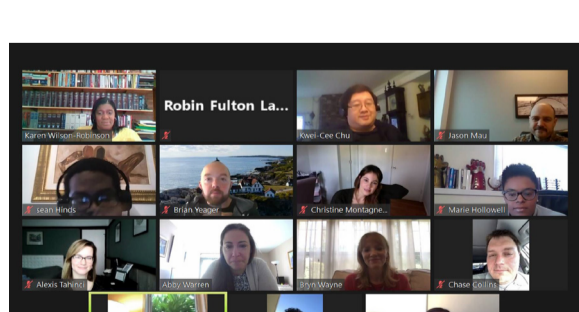
## ANNUAL O'SAVIO MOOT COURT COMPETITION WELCOMES ALUMNI BACK TO CAMPUS
