## DICKINSON LAW SURPASSES CAMPAIGN GOAL, RAISING MORE THAN \$16.9 MILLION



With the final gift logged on June 30—the last day of the University's six-year *A Greater Penn State* for 21st Century Excellence campaign—Penn State Dickinson Law more than achieved its goal.

The Law School raised more than \$16.9 million, bettering its aim of \$16.4 million and showing donors' commitment to educating the next generation of lawyers through accessible, innovative curriculum and programming.
