PANEL FORMED TO REUNITE PENN STATE **DICKINSON LAW AND PENN STATE LAW**



Fourteen students, staff, faculty, and alumni from Penn State Dickinson Law and Penn State Law have been selected to serve on the panel charged by President Neeli Bendapudi with developing recommendations on how to reunite Penn State's two, separately accredited law schools. The panel's first meeting took place Jan. 25. Having received more than 700 nominations for service on the panel, the final candidates were selected based on their expertise with law school operations, capacity to engage in the discussion of collective and shared interests, understanding of the unique strengths of each of the two law schools, and the ability and willingness to promote collaboration in furtherance of the panel's charge. The panel is being led by chair Danielle Conway, dean of Dickinson Law, and vice chair Victor Romero, interim dean of Penn State Law. 
